The deferred stock units are with respect to a \$.04 per common share dividend paid by Issuer on May 2, 2012. The deferred stock units equal the product of the dividend payment amount per share multiplied by the number of deferred stock units credited to the reporting person as of April 18, 2012 (the record date for the dividend) divided by the \$17.58, the closing price of the Issuer's common stock on May 2, 2012 (the dividend payment date).
