#### Item 2.02. Results of Operations and Financial Condition

On November 6, 2007, Lydall, Inc. (the Company) issued a press release setting forth the Company s financial results for the third quarter ended September 30, 2007. Such results have been adjusted to reflect events occurring after the release of preliminary financial results for the third quarter on October 26, 2007. Net income was \$1.9 million, or \$.12 per basic share and \$.11 per diluted share for the quarter ended September 30, 2007, compared to the previously reported net income of \$1.7 million, or \$.11 per basic and diluted share. The Quarterly Report on Form 10-Q, filed by the Company on November 6, 2007, reflects these results.
