INTRODUCTION

This Registration Statement on Form S-8 is filed by Marchex, Inc., a Delaware corporation (*Marchex* or the *Company*) to register an additional 1,852,653 shares of the *Company*'s Class B common stock, par value \$0.01 per share, issuable under the *Company*'s 2003 Amended and Restated Stock Incentive Plan (the *Plan*). This Registration Statement consists of only those items required by General Instruction E to Form S-8.
