- (2) Covers 375,000 additional shares of Common Stock available for issuance under the 2009 Employment Inducement Equity Incentive Plan of Leap Wireless International, Inc., as amended (the Inducement Plan), pursuant to an amendment of the Inducement Plan approved by the board of directors of the Registrant on May 10, 2012. The Inducement Plan authorizes the issuance of a maximum of 775,000 shares of Common Stock. However, the offer and sale of 400,000 shares of Common Stock, which have been or may be issued under the Inducement Plan, have previously been registered pursuant to Registration Statements on Form S-8 (File No. 333-157689 (300,000 shares of Common Stock) and File No. 333-165135 (100,000 shares of Common Stock)).
- (3) This estimate is made pursuant to Rules 457(c) and (h) of the Securities Act solely for purposes of calculating the registration fee, and is based on the average of the high and low prices for the Registrant's Common Stock as reported on the Nasdaq Global Select Market on May 4, 2012.

Proposed sales to take place as soon after the effective date of this Registration Statement as awards granted under the above-named plan are granted, exercised and/or distributed.

EXPLANATORY NOTE

Incorporation by Reference. This Registration Statement is filed pursuant to General Instruction E to Form S-8. Accordingly, the contents of the previously filed (i) Registration Statement on Form S-8 (File No. 333-157689) and (ii) Registration Statement on Form S-8 (File No. 333-165135) are hereby incorporated by reference herein and made a part hereof.

Registration of Additional Shares of Common Stock Under the Plan. This Registration Statement on Form S-8 is filed by the Registrant to register an additional 375,000 shares of Common Stock, relating to equity awards to be granted as inducement awards under the Inducement Plan.
