ING announced today that it has completed the sale of its 70%-stake in ING Funds Berhad, ING s investment management business in Malaysia, to Kenanga Investors Berhad, a wholly owned subsidiary of K & N Kenanga Holdings Berhad.

The sale, as announced on 21 December 2012, is part of ING s earlier announced process to divest ING s insurance and investment management businesses. This transaction does not have a material impact on ING s results and does not impact ING s other businesses in the region.
