Explanation of Responses:

- (1) Includes 60,500 shares of restricted stock grants. 48,000 shares vest on 1/3/08; 10,000 vest on 1/3/10 and 2,500 vest on 8/1/11.
The number of underlying securities is based on the stock fund balance on September 29, 2006. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 29, 2006, stock fund price of \$71.74 per share.
- (2) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (3) The phantom stock units were accrued under the Johnson Controls Equalization 401(k) Benefit Plan and are to be settled 100% in cash upon the reporting person's termination of employment.
- (4) Includes 47.052 phantom stock units acquired through the reinvestment of dividends on September 29, 2006, at a price of \$71.74 per share.
- (5) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's termination of employment.
- (6) Includes 42.139 phantom stock units acquired through the reinvestment of dividends on September 29, 2006, at a price of \$71.74 per share.
Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.
- (7) Includes 240.086 phantom stock units acquired through the reinvestment of dividends on September 29, 2006, at a price of \$71.74 per share.
- (8) Fifty percent of the stock option vests in two years and the balance after three years.
