(1) These shares are held by a local bank as custodian for an IRA. Due to a bookkeeping error these shares were inadvertently omitted from the reporting person's prior reports and is not reflective of any acquisition or sale.

(2) No transaction is being reported on this line. Reported on a previously filed Form 3, Form 4, or Form 5.

(3) The reporting person holds previously reported options to buy 18,569 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between March 2, 2005 and August 20, 2008, at exercise prices between \$23.71 and \$47.01 per share, will expire between March 2, 2015 and August 20, 2018, and became exercisable between December 21, 2005 and September 30, 2012.

(4) The current balance reflects the expiration of 2,000 options on March 11, 2014.
