Election of Directors; Appointment of Principal Officers

On July 8, 2005, Peoples Bancorp Inc. ("Peoples") received a letter, dated July 7, 2005, from John W. Conlon, Chief Financial Officer and Treasurer of Peoples and of Peoples' banking subsidiary Peoples Bank, National Association ("Peoples Bank"), notifying Peoples that Mr. Conlon would retire and resign from his positions as Chief Financial Officer and Treasurer, and as an employee, of each of Peoples and Peoples Bank, effective July 31, 2006. Peoples also announced that Donald J. Landers, Peoples current Controller and Chief Accounting Officer, has been appointed to the position of Chief Financial Officer and Treasurer effective upon Mr. Conlon's retirement.

On July 14, 2005, Peoples issued a news release announcing John W.
