(the "Company") announced on May 11, 2005 that it would be restating its results for fiscal 2004 to reflect certain errors in accounting for inventory at its Tiger Direct, Inc. subsidiary. Until a Form 10-K/A reflecting such restatement is filed, the Company is not in a position to file its Form 10-Q for the quarter ended March 31, 2005 (the "10-Q"). Such delay in filing the 10-Q could not be eliminated by the Company without unreasonable effort and expense.
