AGI US is a directly wholly-owned subsidiary of AGI US Holdings and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, as amended.

The securities reported in this Schedule 13G are held by investment advisory clients or discretionary accounts of which AGI US is the investment adviser. When an investment management contract (including a sub-advisory agreement) delegates to AGI US investment discretion or voting power over the securities held in the investment advisory accounts that are subject to that agreement, AGI US Holdings treats AGI US as having sole investment discretion or voting authority, as the case may be, unless the agreement specifies otherwise. Accordingly, AGI US reports on Schedule 13G that it has sole investment discretion and voting authority over the securities covered by any such investment management agreement. As a result, AGI US may be deemed to beneficially own the securities held by its clients or accounts within the meaning of rule 13d-3 under the Act. Because AGI US Holdings is the parent holding company of AGI US, it may be deemed to beneficially own the securities held by the clients or accounts of AGI US.

In accordance with SEC Release No. 34-39538 (January 12, 1998), this Schedule 13G does not include securities, if any, beneficially owned by subsidiaries or affiliates of AGI US Holdings whose ownership of securities is disaggregated from AGI US Holdings and AGI US in accordance with that release.

AGI US Holdings and AGI US believe that they do not constitute a "group" within the meaning of Rule 13d-5 under the Act and that they are not otherwise required to attribute to each other the beneficial ownership of the securities reported in this Schedule 13G held by them or by any persons or entities for whom or for which AGI US provides investment management services. Each of AGI US Holdings and AGI US also disclaims beneficial ownership of these securities except to the extent of that filer's pecuniary interest therein.
