CVRD Concludes 2004 Iron Ore Price Negotiation with China

Rio de Janeiro, January 15, 2004 Companhia Vale do Rio Doce (CVRD), the world's largest iron ore producer, and Baosteel, China's largest steelmaker, have settled today iron ore prices for 2004.

The new price for the Southern System Fines (SSF), FOB Tubarão, Brazil, of US 32.27 cents per Metric Ton Fe unit, corresponds to a 18.64% increase over the 2003 price and the new price for the Carajás Fines (SFCJ), FOB Ponta da Madeira, Brazil, of US 32.76 cents per Metric Ton Fe unit, corresponds to a 18.27% increase over the 2003 price.

Such settlement was achieved between CVRD and Baosteel after several rounds of negotiation that started in December 2003.
