This prospectus supplement supplements the information contained in the prospectus of Alkermes, Inc. dated November 14, 2003 as supplemented by Prospectus Supplement No. 1 dated June 21, 2004, Prospectus Supplement No. 2 dated August 18, 2004, Prospectus Supplement No. 3 dated November 15, 2004, Prospectus Supplement No. 4 dated November 22, 2004, Prospectus Supplement No. 5 dated December 15, 2004 and Prospectus Supplement No. 6 dated February 23, 2005 relating to the potential resale from time to time of the 2<sup>1</sup>/<sub>2</sub>% Convertible Subordinated Notes due 2023 of Alkermes and the resale of shares of common stock of Alkermes issuable upon conversion of the notes. This prospectus supplement is not complete without, and may not be delivered or utilized except in connection with, the prospectus, including any amendments or supplements thereto.
