On March 17, 2005, Registrant issued a press release announcing that the Board of Directors of Tiffany & Co. (NYSE-TIF) has approved a new stock repurchase program. This new program, effective immediately and expiring March 30, 2007, authorizes the Company to repurchase up to \$400 million of its Common Stock through open market or private transactions. Repurchases in excess of \$159 million will be subject to lender approval under Registrant's primary credit facility. All prior share purchase authorizations have been terminated by the Board of Directors. A copy of the March 17, 2005 press release is attached hereto as Exhibit 99.1 to this Form 8-K.
